NOTIFICATION

Dated, Shillong, the 27th January, 2021

No.LBG.39/2014/Pt/275 - WHEREAS Ease of Doing Business is a priority of the Government of Meghalaya, in consonance with the Business Reform Action Plan of the Department for Promotion of Industry and Internal Trade, Ministry of Commerce & Industry, Government of India;

WHEREAS there is a need to simplify business regulations and ease of compliance of labour laws, and bring in transparency and accountability in the registration and renewals of factory licenses for factories occupiers/owners, to create a conducive environment for business investors and entrepreneurs in the State;

NOW, THEREFORE, the State Government has decided to introduce an online-based auto-renewal system in the Office of the Chief Inspector of Boilers and Factories, Meghalaya; without the requirements for physical visits and submission of hard copies and to eliminate the hassles of physical visits for periodic renewals of factories licenses.

After careful examination of the matter, the Government of Meghalaya hereby decides to implement the process and switch over to the system of auto-renewal with regards to **Renewal of Factories Licenses** under The Factories Act, 1948 and the Meghalaya Factories Rules, 1980.

Under the Auto-renewal system; automatic and non-discretionary renewal license shall be issued after online payment of required renewal license fee, along with penalty (if applicable) in the required format or otherwise based on the correct information provided by the applicant(s).

Detailed guidelines for ensuring the compliance of the provisions of the Factories Act, 1948 and the Meghalaya Factories Rules, 1980 by the licensees will be communicated accordingly.

This Notification is in supersession of Notification No. LBG. 39/2014/Pt/256 dated 22nd December, 2020.

This will take effect from the date of its publication in the official Gazette.
