WHEREAS Ease of Doing Business is a priority of the Government of Meghalaya, in consonance with the Business Reform Action Plan of the Department for Promotion of Industry and Internal Trade, Ministry of Commerce & Industry, Government of India.

Whereas vide letter dt. 17.05.20 the Ministry of Finance, Govt. of India proposed some reforms for allowing states to access additional borrowings of 2% GSDP, to enable conducive business environment in the state.

Therefore, in order to simplify the renewal processes, to eliminate the hassles of renewal of licences the Department of Legal Metrology hereby introduces the Auto-renewal System for Renewal of Licences of Manufacturer, Dealers & Repairers under the Legal Metrology Act, 2009 and the Meghalaya Legal Metrology (Enforcement) Rules, 2011.

Under the Auto-renewal System, the licensee can make an online payment of required renewal licence fee to renew their licenses and the Auto – Generated renewal licences will be issued online or other wise based on the detail and information uploaded by the applicant (s) (establishment) at the time of payment of renewal licence fees etc.

The Auto-renewal system will come into force from the date to be notified by the Government.

Detailed guidelines for ensuring the compliance of the provisions of the Legal Metrology Acts & Rules by the licensees and procedure for the auto renewal process will be communicated accordingly.

Hence, all the Offices of the Department of Legal Metrology in the State will commence to dessiminate information and sensitize all licensees on the newly introduced Auto – renewal process of licences.
